What is EMKIT 2 ?

- An Empowerment Toolkit for Trainers for the Development of the Social and Cultural Competence and Media Literacy for Low Skilled Migrant Women
- A way to show to these women that they are not forgotten and we want them to be integrated to our societies
- Promote and develop the Key Competences of Europe's new citizens in order to promote active citizenship.

Welcome to EMKIT2

EMKIT 2 is aiming in empowering Third Country National (TCN) women and help them integrate in their new European host country. This will take place by providing them with competences that are considered as “key” for European citizens.

EMKIT2 aims to

1. Develop 3 Qualification Frameworks for the Social & Civic (S), Cultural Awareness & Expression(C) and Media Competence(M) (SCM competences) tailored for the specific target group in a specific context (see innovation elements)
2. Based on the Learning Outcomes of the QFs developed enrich activities offered at each stage by designing 42 new workshops for the development of the SCM competences.

3. Develop 42 digital tools for the newly developed workshops for trainers for the development of the SCM competences and incorporate them in the existing EMKIT online tool.

4. Introduce & develop a digital assessment tool and incorporate it on the existing EMKIT toolkit. EMKIT was developed for women who live in isolation and need to progress through all stages to reach active citizenship. Through the use the EMKIT (for 6 years now) it has been evident that a) a systematized method is needed for an impartial assessment of the stage a woman is in and to avoid unnecessary activities that are tailored for women who are at a lower stage of the scale b) validate the results of the empowerment process. Therefore this project suggests the develop-

ment of an assessment tool in order to identify the stage of the woman and validate the Learning Outcomes of the activities implemented at each stage

Target groups of the Project

The **direct target** group is trainers/mentors who work with migrant women (i.e. trainers/mentors in Adult Education implementing projects funded by Integration Funds/Daphne/Justice and mentors working at NGOs/associations). Trainers

will benefit by a more complete EMKIT tool that also develops 3 important context specific competences (i.e. SCM competences for low skilled migrant women to achieve AC)

The final recipients of the project outcomes will be low

skilled women that are TCNs in their host country and wish to further progress and integrate in their new society.
